



### Florida-Specific Assembly Checklist & Assembler Authorization for Infiltrator Tanks

Please read each line of the following checklist items carefully and initial each line to confirm that you both understand and will perform the required tasks for each Infiltrator Water Technologies tank that you assemble.

#### Assembly Checklist:

- I have access to the proper equipment to off-load the tank pallet from the flatbed truck with pallet forks. Minimum requirements: a forklift with 66" fork length (extensions are acceptable) and 10' pick height. Minimum requirements vary by tank.
- I understand that the lifting straps provided in the starter kit can be used to lift no more than two tank halves at one time.
- I have reviewed the applicable Infiltrator tank assembly instructions and understand each of the following critical steps:
  - Inspect the tank pallet and/or starter kit and confirm that all components/materials are present (see materials list) and in good condition.
  - Visually inspect every tank body to verify no damage and record results on the applicable **Florida Assembly Log**.
  - Lift bottom half of tank and place in assembly area. Protect the tank halves from dirt and damage.
  - Verify that the gasket is properly seated in the lower tank half groove and use a coarse-bristled paint brush or clean rags to remove any dirt or debris from the gasket. Evaluate the gasket around the entire length to verify that it is level with the tank surface (does not undulate).
  - Insert all dowel/alignment pins on bottom tank half (does not apply to IM-300, CM-1060, or IM-1250).
  - For two-compartment tank configurations, remove the perforated baffle port openings in accordance with applicable regulator approval using a hammer. Fold and insert corrugated baffle wall in baffle groove.
  - For two-compartment tank configurations, make sure baffle wall indexing groove matches the indexing ribs on the tank and is properly oriented.
  - Apply an even coat of soapy water to exposed gasket.
  - Lift top half of tank and align with dowel/alignment pins.
  - Carefully lower top half of tank onto bottom half and visually verify that the gasket is properly seated in each tank half.
  - Install two locking clips in each of the four "corners" of tank and rotate tank 45 degrees to provide access into openings in tank upper half.
  - Insert a fiberglass support post into each molded post seat, as applicable.
  - Unfold corrugated baffle wall and secure tie wraps to fiberglass support post (two-compartment tank only).
  - Install the remaining locking clips working your way around the perimeter of the tank.
  - Visually inspect the gasket to verify proper installation and record results on the applicable **Florida Assembly Log**.
  - Vacuum test tanks at the minimum frequency prescribed on the **Florida Assembly Log** and record results on the applicable **Florida Assembly Log**.
  - Mark the tank inlet using the Inlet Marking Tool and drill the tank inlet and outlet using a 5" hole saw.
- I will not assemble the Infiltrator tank at a job site or under uncontrolled conditions.
- I have witnessed and participated in a complete Infiltrator tank assembly demonstration with Infiltrator Water Technologies.
- I have read the secondary instructions regarding the safety requirements for a completed vacuum test (where applicable).
- I have read the secondary instructions regarding the safety requirements for a completed water leak test (where applicable).
- I have read and understand the Infiltrator Septic Tank Limited Warranty.
- I agree not to sell any unassembled (two shells) tanks to any person or company unable to show proof verifying their authorization by Infiltrator to assemble Infiltrator Tanks (every tank serial number is linked to the authorized distributor where the tank was delivered).
- I agree that Infiltrator Tanks will only be assembled by employees of my organization who are under responsible charge of an individual who has been trained by Infiltrator Water Technologies.
- I agree to fax completed Florida Assembly Logs to 860-577-7993 for each pallet of tanks assembled.

#### Assembler Authorization:

Your initials on the lines above and signature below confirm that you understand each step in the process of assembling an Infiltrator tank. Infiltrator gives you the authority to assemble and deliver assembled tanks. Infiltrator Water Technologies will extend additionally insured coverage to authorized Infiltrator tank assembly partners that agree to the terms on the Assembly Checklist above in accordance with the following:

- Coverage will be extended only when this signed checklist is returned to Infiltrator Water Technologies corporate headquarters in Old Saybrook, CT.
- Authorized Infiltrator tank assembly partners will receive an insurance certificate from our insurance provider. If you do not receive a certificate in a timely manner, please follow up with your local sales representative.
- As an authorized Infiltrator tank assembler, Infiltrator's general liability policy extends additional insured coverage to you by way of a vendor's liability endorsement. This means that you will have coverage under Infiltrator's policy for bodily injury or property damage arising out of Infiltrator Tanks that you assemble, distribute or sell. The coverage afforded to you is subject to the terms and conditions of the policy. A good example of an action that would invalidate your additional insured status would be your failure to follow the above Assembly Checklist and the Infiltrator tank assembly instructions.
- Additionally insured coverage does not provide replacement coverage for the actual product (i.e. property damage resulting from a

FIVE (5) YEAR MATERIALS AND WORKMANSHIP LIMITED WARRANTY**

(a) This limited warranty is extended to the end user of an Infiltrator Tank. A Tank manufactured by Infiltrator, when installed and operated in accordance with Infiltrator's installation instructions and local regulation by a person or company that is properly qualified to install the Infiltrator tank in accordance with applicable state and/or local requirements, is warranted to you: (i) against defective materials and workmanship for five (5) years after installation. Infiltrator will, at its option, (i) repair the defective product or (ii) replace the defective materials. Infiltrator's liability specifically excludes the cost of removal and/or installation of the Tank.

b) In order to exercise its warranty rights, you must notify Infiltrator in writing at its corporate headquarters in Old Saybrook, Connecticut within fifteen (15) days of the alleged defect.

(c) YOUR EXCLUSIVE REMEDY WITH RESPECT TO ANY AND ALL LOSSES OR DAMAGES RESULTING FROM ANY CAUSE WHATSOEVER SHALL BE SPECIFIED IN SUBPARAGRAPH (a) ABOVE. INFILTRATOR SHALL IN NO EVENT BE LIABLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, HOWEVER OCCASIONED, WHETHER BY NEGLIGENCE OR OTHERWISE. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THIS LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

(d) THIS LIMITED WARRANTY IS THE EXCLUSIVE WARRANTY GIVEN BY INFILTRATOR AND SUPERSEDES ANY PRIOR, CONTRARY, ADDITIONAL, OR SUBSEQUENT REPRESENTATIONS, WHETHER ORAL OR WRITTEN. INFILTRATOR DISCLAIMS AND EXCLUDES TO THE GREATEST EXTENT ALLOWED BY LAW ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTY OF MERCHANTABILITY, FINESSE FOR A PARTICULAR PURPOSE AND ANY IMPLIED WARRANTIES OTHERWISE ARISING FROM COURSE OF DEALING, COURSE OF PERFORMANCE, OR USAGE OF TRADE. NO PERSON (INCLUDING ANY EMPLOYEE, AGENT, DEALER, OR REPRESENTATIVE) IS AUTHORIZED TO MAKE ANY REPRESENTATION OR WARRANTY CONCERNING THIS PRODUCT, EXCEPT TO REFER YOU TO THIS LIMITED WARRANTY. EXCEPT AS EXPRESSLY SET FORTH HEREIN, THIS WARRANTY IS NOT A WARRANTY OF FUTURE PERFORMANCE, BUT ONLY A WARRANTY TO REPAIR OR REPLACE.

(e) YOU MAY ASSIGN THIS LIMITED WARRANTY TO A SUBSEQUENT PURCHASER OF YOUR HOME.

(f) NO REPRESENTATIVE OF INFILTRATOR HAS THE AUTHORITY TO CHANGE THIS LIMITED WARRANTY IN ANY MANNER WHATSOEVER, OR TO EXTEND THIS LIMITED WARRANTY.

(g) NO WARRANTY OF ANY KIND IS MADE WITH REGARD TO ANY PRODUCT, COMPONENTS, DEVICES, MEDIA OR TREATMENT UNITS WHICH ARE MANUFACTURED BY OTHERS AND ARE INSTALLED IN AN INFILTRATOR TANK. USE OF THESE PRODUCTS ARE AT YOUR OWN RISK.

(h) THE INFILTRATOR TANK IS DESIGNED TO BE BURIED UNDERGROUND. NO WARRANTY OF ANY KIND IS MADE IF YOUR TANK IS NOT BURIED UNDERGROUND AS SPECIFIED IN THE PRODUCT'S INSTALLATION INSTRUCTIONS.

**CONDITIONS AND EXCLUSIONS**

There are certain conditions or applications over which Infiltrator has no control. Defects or problems as a result of such conditions or applications are not the responsibility of Infiltrator and are NOT covered under this warranty. They include failure to install the Tank in accordance with instructions or applicable regulatory requirements or guidance, altering the Tank contrary to the installation instructions and disposing of chemicals or other materials contrary to normal tank usage.

The above represents the Standard Limited Warranty offered by Infiltrator. A limited number of states and counties have different warranty requirements. Any purchaser of a Tank should contact Infiltrator's corporate headquarters in Old Saybrook, Connecticut, prior to such purchase to obtain a copy of the applicable warranty, and should carefully read that warranty prior to the purchase of a Tank.
