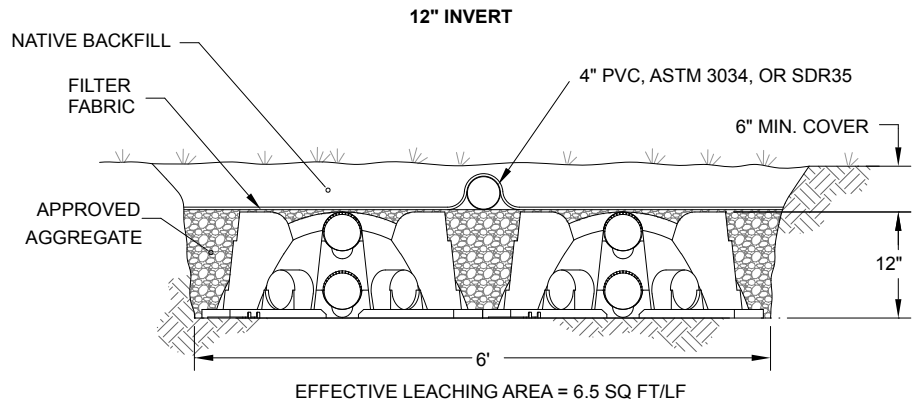
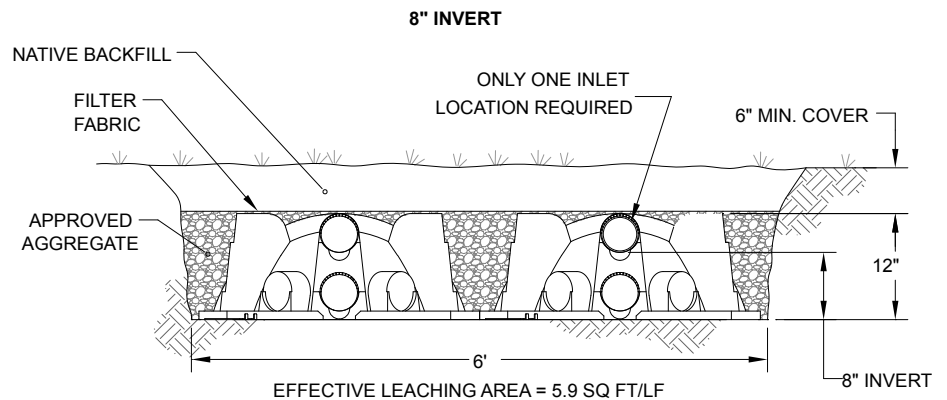

### Quick 4 Standard TYPICAL CROSS SECTION (not to scale)



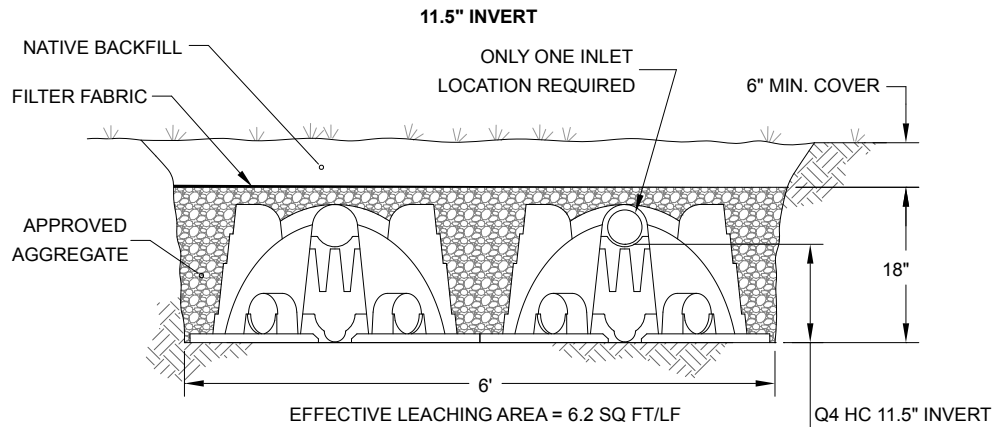

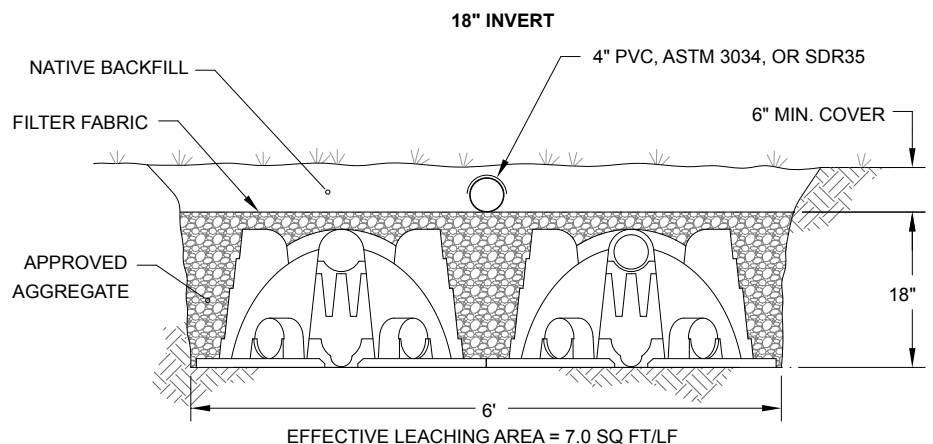

TYPICAL CROSS SECTION (not to scale)

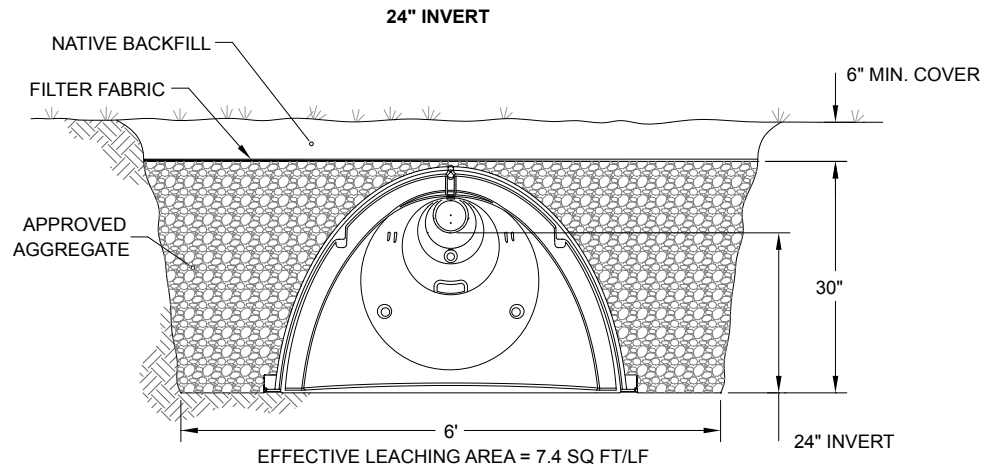

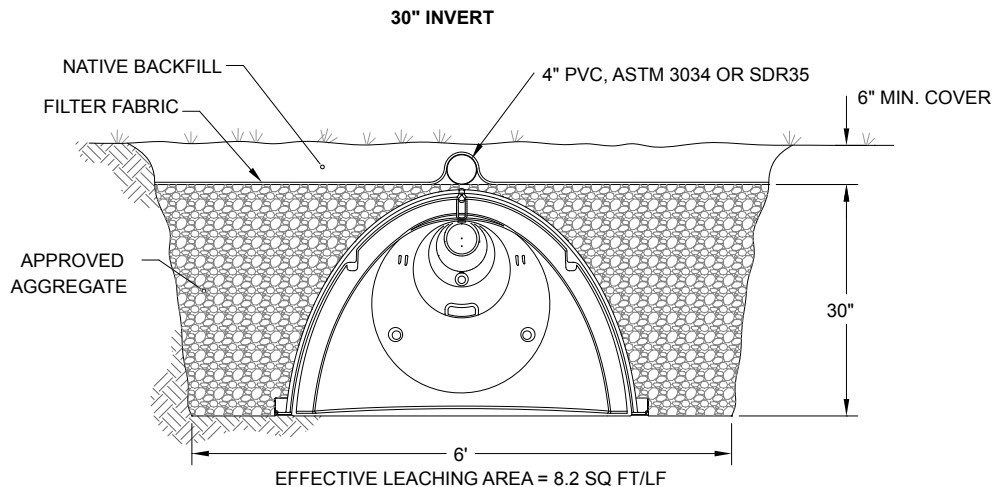
